Additionally, it has been formulated to offer superior crack-resistance and lower shrinkage.

Ultima Light compound is manufactured under strict quality controls to meet ASTM C-475 (Standard Specification for Joint Compound and Tape Finishing Gypsum Board) using first-class raw materials and technology that offers the quality that is expected from Panel Rey® across its entire range of products.

Ultima Light X is used in taping, joint finishing, corner molding, fastener repair, texturing, and drywall crack repair. This compound provides an ideal surface to apply paint or any desired finish thanks to the smooth surface after drying.

Recommendations

- Keep the product in suitable storage conditions, avoiding prolonged exposure to the environment and temperatures below 10 °C, even during its application.
- Apply to clean and completely dry surfaces.
- When being applied as a texture product, it may require dilution; It is recommended that clean water be added in small portions of up to 2% water by weight of the product to avoid excess water that causes lack of adherence or cracking.
- The warranty date of the product is 6 months after its date of manufacture. It is recommended that inventory be rotated and do not use product that has spent more than the recommended shelf-life in storage.
- Keep out of the reach of children. Review safety precautions.

Joint treatment procedure:

It is recommended to apply 3 coats of Ultima Light X by Panel Rey® be applied to adhere and embed the joint tape and then prepare the surface for the final finish.

If it is determined that the finish requires or warrants it, use wet sandpaper to sand the edges to achieve perfectly smoothness.

Apply each coat after the previous coat has completely dried.

Finishing

When using base paint, texture, etc., it must be anchored with a vinyl sealer in line with the recommendations provided by the manufacturer. For stone finishes, use an adhesive recommended by the manufacturer or distributor of these finishes. It is recommended never to tear off the paper from the drywall because far from improving adhesion, it weakens the drywall core.

Precautions

Avoid dust by wet sanding. Wear a mask and safety glasses. Dust created by sanding or mixing can cause eye, nose or throat irritation. If eye contact occurs, rinse thoroughly with water for 15 minutes to remove particles. If irritation persists, contact a physician. Do not ingest the product. KEEP OUT OF REACH OF CHILDREN.
